Each year the Wells Ogunquit Senior Center holds its joint Annual Membership and Board of Directors Meeting. It is during this meeting that the open seats on the Board of Directors are voted in, and any proposed By-Laws changes are voted on. A ballot box and ballots were available for Members to vote for the candidates of their choice, as well as a referendum questions that require member feedback. It is especially important that our members of the Senior Center have - AND TAKE - the opportunity to participate in the governance of our organization. Eighty-one votes is an amazing number!
